he 2006 Tobacco Tax Resolution is reproduced below. This resolution is being circulated by a growing collaboration of traditional (American Cancer Society, Coalition for a Tobacco Free Vermont, Heart & Lung Associations) and nontraditional anti-tobacco organizations, like Outright Vermont!

Essentially, this resolution is an important piece of a larger campaign to address, prevent and stop tobacco use here in Vermont. Our hope is to have the tobacco tax increased on both cigarettes and chewing tobacco by the end of the 2006 legislative session. (The last increase was in 2003 for cigarettes, but other tobacco products haven't had a tax increase in 10 years!) It has been proven that one of the effective ways to decrease smoking rates across the board, is to continue to


make the tobacco products out of the price range of those who might use them. Plus, the revenue raised by the tobacco tax can and does get returned to tobacco prevention efforts. These efforts help round out the holistic approach that is needed to complete prevention work (quit

Coalition for a Tobacco Free Vermont Resolution to Reduce Tobacco Use and Improve the Health of Vermonters

WHEREAS, Every year, 1600 Vermont children become addicted to tobacco and 14,000 kids under 18 alive today in Vermont will die prematurely from smoking³; and

WHEREAS, increasing Vermont's cigarette tax by 81 cents to \$2.00 would significantly reduce the number of youth who smoke, would save a projected \$102.8 million in long term health care costs, and would provide additional state revenues, including an estimated \$19.6 million in FY2007'; and

WHEREAS, currently 12% of high school boys (up from 8% in 2003) and 2% of high school girls (up from 1% in 2003) use chew/spit tobacco; ³

WHEREAS, currently Gay, Lesbian, Bisexual and Questioning (GLBQ) youth are more than two times more likely to smoke than their heterosexual peers¹;

WHEREAS, currently the smoking rate of low income Vermonters is significantly higher than Vermonters in higher income groups, and continues to rise where other populations are decreasing.

WHEREAS, Vermont has the second lowest eigarette tax in the region including all of New England, New York

WHEREAS, funds from the tax increase would support state programs that will advance the health of all

- BETTTHEREFORE RESOLVED, that the undersigned organization endorses:

 Increasing the Vermont cigarette tax by 81 cents; and all other tobacco products (OTP) tax from 41% to 90% of wholesale price (first increase since 1995);

 Using money raised by this increase in the cigarette and other tobacco taxes to fund state programs that will advance the health of Vermont citizens.

BE IT FURTHER RESOLVED, that the undersigned organization will:

- Inform its members and, if possible, the general public of its endorsement of this Resolution; and,
 Inform the Governor and members of the Legislature of its endorsement of this Resolution, to the extent permitted by law, and urge its constituency to do so.
