## Dear Gert and Alice:

This past week I received a call from my sister (who lives in Massachusetts). I told her about a relationship that I'm involved in and that I was at the March on Washington. Each time I approach the subject of being gay she changes the subject or gives me no response. I care about her deeply but it takes a lot of energy to keep trying with no reaction.

With her living so far away it somehow seems easier to just avoid the topic. With the holidays approaching I am wondering what I should do? (P.S. - I love your column!)

Dear Confused:

First, we applaud your being out to your sister in the first place. We know this takes a lot of courage.

It sounds as though your sister is at a certain stage of acceptance (or non-acceptance!) which might or might not change. Since she is an important person to you, give it another try.

Have you pointed out to her that she changes the subject or doesn't respond when you talk about things related to your gay lifestyle? You might want to say, "Hey, when I talk about my life, you change the subject, which doesn't make me feel very good. Can we talk about this?" Or words to that effect.

This IS a difficult situation, and all the "communicating" can't come from you-- she has to put in some effort, too. You might also want to send her articles, books or other materials regarding lesbian or gay life (hey! You could send her "Gert and Alice"!!! But you'd need a very large envelope for the two of us). This way she can become better informed at her own pace, without pressure. Please write to us again and let us know how it turns out.
