Lambda Sues U.S. Naval Academy for Forced Resignation of Gay Midshipman

Fund announced that it has filed suit in Federal District Court for the District of Columbia charging the U.S. Naval Academy with forcing Joseph Steffan, a highly commended midshipman, to resign less than two months before he was to graduate and receive his commission in the U.S. Navy soley because he was gay.

"Joseph Steffan's distinguished record of achievement was totally unblemished" stated Sandra J. Lowe, the Lambda Staff Attorney representing Steffan. "He was a class service leader, a military leader, and was ranked in the top of his class academically. In every way, he was and is the best that the Naval Academy has to offer."

In his suit Mr. Steffan charges that his forced resignation violated his rights to
