HRCF Joins Amicus Brief in Supreme Court Abortion Case

The Human Rights Campaign Fund (HRCF), joined 76 other organizations committed to women's equality in a friend-of-the-court brief supporting women's right to reproductive freedom. The brief, prepared by the National Abortion Rights Action League and Women's Legal Defense Fund, was filed in the U.S. Supreme Court case *Webster v. Reproductive Health Services*.

The case- now being considered by the nation's highest court- addresses a Missouri statute that restricts women's right to choose abortion.

HRCF's participation in the amicus curiae brief in *Webster* reflects its continuing commitment to work with organizations dedicated to civil rights and the equality of all persons. The American Civil Liberties Union, the National Abortion Rights Action League, the National Organization for Women, and Planned Parenthood are among the groups with which HRCF works on a wide range of legislative and political activities.

NGLTF Releases National L&G Civil Rights Bill Lobbying Packet

The National Gay and Lesbian Task Force (NGLTF) released a lobbying packet for use by constituents and supporters of the federal Lesbian and Gay Civil Rights Bill. The bill, known as the Civil Rights Amendments Act of 1989, prohibits discrimination in employment, housing, public accommodation, and federally assisted programs on the basis of affectional or sexual orientation.
