Burlington Police Meet Gay Community

On May 25, eight Burlington police officers met with members of the gay and lesbian community in an open forum to discuss issues of concern.

The meeting, arranged at the request of Officer Greg Knight of the Community Based Police (CBP), was moderated by Howdy Russell. About 20 men and women attended the meeting. Representative from the Police Department included all but one of the Community Based Police Officers, Sgt. Mike Rogers, CBC Supervisor and Lt. Emmet Hillard, the Police Department night shift supervisor.

The officers introduced themselves and talked about the role of the CBP and their reasons for attending the meeting. Ac-

cording to Officer Robert Moore, "Our #1 goal is to create a better living environment help people get to know and develop a relationship with a local cop." Officer Knight the lack of trust the gay community has in the police and the fact that in many cases, people will not call on the police for help. Community members described concerns and fears of the police and the "system" and gave some background on why many people feel the way they do.

The meeting provided both police and community members an opportunity to exchange opinions and concerns. It was part of the Police Department's ongoing effort to reach out to Burlington's minority communities and provide service to them.
